During November the Draft Neighbourhood Plan for our Parish underwent scrutiny by Cheshire West and other interested bodies. In the main their submissions were relatively benign, but amongst them were some that may require review – two are listed below;

- I. Fisher German, a property consultant based in Chester, who has put forward, a submission that includes a proposition to develop the plot

of land bordered by John Street, Quarry Bank and Tirley Lane. This is on behalf of a local farmer (Mr A Hassall) and it broadly followed a plan set out in strategic land studies for Cheshire West related to their Local Plans. It



suggested that *‘based on the sites inclusion in the HELAA 2017 under TAR/0065 Rural Land at Quarry Bank / John Street, Utkinton being deemed a suitable, available, achievable site for approximately 67 dwellings (HEELA pp. 109).’*

- II. Birmingham based planning consultancy (RPS Consulting Services Ltd) have submitted and state that it *‘...has been instructed to submit representations on behalf of our Client to the above Regulation 16 consultation, ahead of the submission and Examination of the Plan. Our Client is a stakeholder with interests within in the Neighbourhood Plan*

area'. Their submission focussed on Cotebrook and it led the Parish Council to believe that they have already 'earmarked' potential sites capable of supporting development. Further, it also suggested that the Draft Plan does not proceed to examination.
